In early August 2014, Delaware Arts Alliance (DAA) emailed a survey to all candidates in the upcoming Delaware elections (for whom valid email addresses could be obtained). Candidates were asked to state their positions on various legislative matters as they relate to the arts and arts education in Delaware. Presented below are all the responses received as of August 29.

Responses appear exactly as they were received, and have not been edited in any way. Candidate names, offices pursued, and party affiliations are based on how they appear in the <u>Statewide General Candidate Listing</u> in the Delaware.gov website as of September 2.

QUESTION #1:

What role do you believe government should play in supporting the arts to enhance economic development (i.e. creative districts, revitalization of low-income neighborhoods, etc.)? Please explain what option you choose and the reasons for your selection.
